SONJA ANTONIĆ (1984) attends the graduate master studies of Philosophy at the Department of Philosophy, Faculty of Philosophy, University of Novi Sad.

SERGIO BELARDINELLI (1952). In 1975. he graduated in Philosophy at the University of Perugia and in 1979-1980 . He was granted a fellowship by “Alexander von Humboldt-Stiftung” at the University of Munich. From 1979. to 1989. he taught Philosophy of labour and Philosophy of History at the Faculty of Political Science at the University of Trieste. Since 1992. he is a full Professor of Sociology of Culture at the Faculty of Political Science “Roberto Ruffilli” at the University of Bologna, Forli campus. He has been a Visiting Professor at many foreign universities. Between 2002 and 2006 he was a member of the italian “National Bioethics Committee”. Some of his books: *Normality is the exception. ANTE ČOVIĆ (1949) is a Full Professor at the Department of Philosophy at the Faculty of Philosophy, University of Zagreb, and the chairman of the section for ethics. He has published numerous articles on the subject of ethics, bioethics and other philosophy domains. He was the chief editor of “*Filozofska istraživanja*” journal and the international publication “*Synthesis philosophica*” (1983-1993). He is an editor of “*Filozofska istraživanja*” and “*Bioetika*” editions. Also, he is the researcher in chief on the project called “*Bioethics and philosophy*” and co-chairman of the organizational committee “*Lošinj’s days of bioethics*”.

MICHAEL FUCHS studied philosophy, germanistics and catholic theology at Bonn, Toulouse and Köln. He was promoted at the Faculty of Philosophy in Bonn. He was sci-

entific Assistant at the Institute for Science and Ethics and Assistant at Philosophy Seminar at the University of Bonn. Fields of research: philosophy of nature, anthropological and ontological problems of individuation and individualism of living beings.
